Prices are calculated according to the total length of the vessel, including bow extensions, anchors, stern platforms, etc. The marina reserves the right to measure each vessel. The berth is charged from the day of the written reservation of the berth.

Annual wet berth includes:

- wet berth
- use of sanitary facilities
- use of drinking water
- use of electricity for lighting
- one parking space per vessel
- Wi-Fi
- video surveillance 24/7 and sailor assistance

Option:
Premium berth with all of the above includes a finger, i.e. a side access to the boat or A gat berth. The price increases by 1000 €

Monthly and daily wet berth includes:

- wet berth
- use of sanitary facilities
- use of drinking water
- use of electricity for lightning
- Wi-Fi
- video surveillance 24/7 and sailor assistance
- the wet berth is not fixed and it can be changed
- the vessel owner is obliged to leave the berth by 2 pm the next day

Option:
Premium berth with all of the above includes a finger, i.e. a side mooring and access to the boat. The price increases by 45%
15% off daily rate after 3 consecutive days
30% off daily rate after 20 consecutive days
The daily berth fee is reduced by 20% from October 1st 2023 to April 30th 2024

Combined berth (sea and land) includes everything that is included in the annual wet berth and additionally:

- one lifting out of the sea
- washing the underwater part with a high-pressure pump
- transport to the vessel storage facility
- vessel placement on keel blocks or your own boat trailer in the storage facility
- transport to the sea
- vessel lowering into the sea

Option:
Premium berth with all of the above includes also a finger, i.e. a side mooring and access to the boat or place berth od Gat A

1 crane operation - lifting or lowering

Use of the place on land is free for 3 days for users of the annual wet berth

Staying on the crane slings up to 1h = 1 operation, longer than 1h = 2 operations

Mitan marina reserves the right not to lift the vessel in case it does not have the means and place on land

Underwater washing is performed exclusively in the designated place under the crane

Annual berth in storage facility:

- one lifting out of the sea and washing the underwater part
- transport to the vessel storage facility
- vessel placement on keel blocks or your own boat trailer in the storage facility

- transport to the sea and lowering into the sea
- video surveillance
- 1 parking space for a car at the place of the vessel when it is outside the storage facility
- 10% discount if the boat has an associated trailer

Monthly and daily berth in the storage facility include:

- vessel accommodation in vessel storage facility 3 km away from the marina
- vessel placement on keel blocks or your own boat trailer in the hangar
- video surveillance 24/7
- use of sanitary facilities and drinking water

Monthly and daily berth outdoors include:

- vessel accommodation in vessel storehouse area 3 km away from the marina
- vessel placement on keel blocks or your own boat trailer outdoors
- video surveillance 24/7
- use of sanitary facilities and drinking water

GENERAL PROVISIONS AND RULES OF CONDUCT WITHIN THE PORT OPEN TO PUBLIC TRAFFIC MITAN MARINA (further in the text: MITAN MARINA)

The provisions of these general conditions apply to all owners or users of vessels and persons residing or located in the premises of the port. Upon entering the area of the port of Mitan marina, all provisions of these general conditions, the Ordinance on maintaining order in the port open to public traffic, the General conditions of the Mitan marina and other official acts displayed at the port, notice board or reception of the port are accepted.

MOORING

Mitan Marina determines the berth of the vessel in accordance with its berth plan and is authorized to move each vessel to another berth if necessary. Every user of the vessel must have vessel insurance for damage done to other vessels, people or the marina. The marina has the right to determine special conditions for special boats that require special treatment. It is considered that the vessel was handed over after fulfilling and signing the contract, inventory list, and handing over the keys and navigation license of the vessel at the reception. Mitan marina is not responsible for vessels not handed over in this way.

ARRIVAL TO THE PORT AND MOORING

Before navigating into the port, vessels are obliged to request permission to enter from the maritime service by radio using channel 17. Upon arrival at the port, the master of the vessel is obliged to hand over the navigation license and the crew list at the reception. During navigation in the port zone, the vessel must move at the lowest possible speed. The mooring of the vessel must be done in a safe way, with the proper ropes of appropriate dimensions. Moored ropes must not interfere with the navigation of other vessels. If the vessel is not properly moored, this will be done by the port employee at the expense of the vessel user. The connection to the electrical distribution cabinet is only permitted with the working electrical cables with the power allowed on the electrical distribution cabinet socket. The connection to the water supply installation can only be done with the working pipes that have a shut-off valve at their end.

PERMANENT BERTHS

Upon arrival to the port, guests are required to register their stay at the reception, with presentation of an identity card or passport, in accordance with legal regulations. The master of the vessel is obliged to report any departure from the port. The user of the vessel is obliged to report to the reception every absence of the vessel longer than 24 hours, and the return should be announced at least 24 hours in advance. Upon departure the owners of the vessel on an annual berth are obliged to store all the mobile equipment of the vessel indoors, and to hand over the keys and the navigation permit to the reception. If guests have certain requirements that are not specified in the Berth contract, this should be regulated separately. In case of late payment of the annual berth, legal default interest is charged.

DEPARTURE FROM THE PORT

Before leaving, the user is obliged to pay for all the services used in accordance with the valid price list. Mitan Marina may retain the vessel or the guest's belongings until the guest has fully settled the debt. If the vessel leaves the marina by land, all operations of lifting the vessel and loading into the vehicle are performed through the reception.
